Jerry Kaup moved to give the State Librarian authority to use his discretion to negotiate the application adjustments with Underwood, Washburn, Stanley, Glenburn, Hazelton-Moffit-Braddock; 2nd by Ellen Kotrba; unanimous.

Jaugstetter reminded Council they meet at 9:00 in the morning for open forum at the NDSL Workshops - seven members plan to be there.

Discussed open forum at NDLA and decided to have Council plan to host an open forum in Grand Forks Saturday, September 26.

Jaugstetter reported Bernnett Reinke's and Rita Traynor's terms expire this year and are eligible for another term.

LV2004 Grant Awards will be announced in about a week.

Council will meet May 27 at the Heritage Center, 10:00 a.m. to award LSTA grants.

Cindy Larson suggested Council needs to deal with funding for LV2004 grant dollar figure, she needs an amount by mid June. \$125,000 will stay in NDSL base budget, anything over has to be an optional budget over and above the 95% budget.

Agreed there is a need to focus on getting LV2004 through the legislature.

The State Library will prepare narrative evaluations for LV2004 grants.
