Social Networking in Libraries

Setting up and using Web 2.0 tools is easy, but creating policies, assigning responsibilities, measuring effectiveness, and simply continuing to have things to say after the first two months is challenging. LearningExpress Library is a comprehensive online learning platform of practice tests and tutorial courses. This session will show how to set up a LearningExpress Library account, explore content of the database, how to sign up for a test, and look at the E-books that are included. LearningExpress Library has something to offer everyone.

A Career in Libraries? There's a Grant for That!

The State Library Master of Library and Information Science (MLIS) grant is available on an ongoing basis, with applications being accepted at any time throughout the year. The grant, which requires that recipients be North Dakota citizens and also be enrolled in an American Library Association accredited school, may be used to pay tuition, university fees, and textbooks required to complete the course of study. Grant recipients must work full-time in a North Dakota library for two years following the completion of their degree. Grant awards will range from a minimum of \$1,000 to a maximum of \$7,000 and are awarded on a competitive basis. Children's Internet Protection Act: What You Should Know

The Children's Internet Protection Act (CIPA) is a federal law enacted by Congress to address concerns about access to offensive content over the Internet on school and library computers. CIPA imposes certain types of requirements on any school or library that receives funding for Internet access or internal connections from the E-rate program – a program that makes certain communications technology more affordable for eligible schools and libraries. In early 2001, the Federal Communications Commission issued rules implementing CIPA.

In addition to E-rate funding, the Children's Internet Protection Act established new Internet safety requirements for the Institute of Museum and Library Services (IMLS) State Grants Program. Under the State Grants Program, IMLS awards financial assistance to State Library Administrative Agencies, which, in turn, use the funds for statewide activities or to make sub-grants to enhance local library activities. The North Dakota State Library must provide assurance to IMLS that all Library Services and Technology Act State Grants Program funds will be used in accordance with CIPA's requirements.

Library eBooks Can Have Positive Effect on Publisher Sales and Profits

A recently published white paper by a leading distributor of eBooks, audiobooks, music, and video, shows how library collections of eBooks can still drive sales of books, eBooks, and audiobooks in the retail market. Citing examples such as advances in copyright technology; promotion and advocacy of authors, genres, and new formats; and even a direct link from library catalogs to retail websites that allow purchasing, the evidence presents a persuasive argument. Just

as traditional library lending of print materials does not slow or stop retail sales of printed books, neither does library lending of electronic items put a damper upon retail sales of electronic items.
