## Legislative Wrap-Up by State Librarian Mary Soucie

The biennial legislative session ended on April 30 in the early hours of the morning. There were over 1,000 bills filed this session between the two chambers. The State Library's budget was included in HB1013 and was the base case scenario. While the State Library did have to eliminate one position, State Aid for public libraries and the Library Vision program were both funded at the same levels as the last two bienniums. We are grateful to the Legislative bodies for recognizing the importance of supporting libraries.

The State Library, in partnership with the North Dakota Library Coordination Council, worked with Senator Erin Oban on SB2157, which amended the seats on the Council. There will now be one higher education seat that can be filled by anyone from a public or private entity. There are now two at-large librarian seats that can be filled by anyone working in a North Dakota library; in addition to the conversion of the former private higher education seat, the seat that had been dedicated to special libraries was changed to an at-large position as well. We are hopeful that this will make it easier to fill the seats when there is a vacancy.

The NDLA Legislative Committee tracked bills and kept the library community informed about the session. One bill that I gave testimony on for both NDSL and the larger library community was HB1349, which amends several sections of the Open Meetings Act in Century Code. The areas of most interest to the library community are the changes to 44-04-19 Access to public meetings. After August 1, 2021, libraries will need to include a link for how to access all online public meetings. You may not instruct members of the public to call the library for the link. You may, however, post the link for how to register for the meeting and then send the link for the meeting to those who register. You must also make sure that a meeting has the capacity to hold the expected number of attendees, whether the meeting is held in person or online. Overall, this session was a positive one for libraries, and we are thankful for the support of the Executive and Legislative branches.





## New Book Club Kit *This Heart of Mine* by C.C. Hunter

This month, we are highlighting one of the State Library's newest book club kits: *This Heart of Mine* by C.C. Hunter.

C.C. Hunter is a beloved Young Adult author known more for her fantasy novels than contemporary ones. However, with *This Heart of Mine*, Hunter sticks closer to realism—a girl receives a heart transplant from a boy at her school after he supposedly kills himself. While it would be tempting for many to dwell in the darker and more emotional aspects of this story, Hunter paves the way forward to look at the mystery of dream connections, first love, and the grief of a family all infused into a teen mystery thriller.

Kits can be checked out for eight weeks and reserved up to one year in advance. Book club kits can check out to libraries or individual patrons; no more than three kits can be checked out at one time.
