Dating Photographs

Let's talk about dating photographs. No, I'm not talking about taking photos to dinner and a movie. I'm talking about determining the date (as in the year) of photographs.

Undated photos can often be quite a mystery, but it's important to remember that the date does not have to be perfect. In fact, it is likely that you will not be able to determine an exact year. However, date ranges (like "1920-1930" or "late 1940s") are better than nothing.

The **Digital Initiatives department** often encounters photographs without dates. This is especially true with **ScanDay** events (pre-pandemic). Participants were frequently uncertain about the date of photographs they bring in. This resulted in Digital Initiatives creating a **handout and a LibGuide page** on this topic (both also include links to additional resources to make your life easier).

This article will explore some of the tips and tricks available on the handout and LibGuide. So, let's look at the four easy ways to determine the date (or date range) of a photo: Format, Details, Photographer/Studio, and People.

Time is Ticking for Applying for the Emergency Connectivity Fund

The <u>Emergency Connectivity Fund</u> is a \$7.17 billion program funded by the American Rescue Plan Act of 2021 to help schools and libraries support remote learning. The Program will provide funding to schools and libraries for the reasonable costs of eligible equipment and services that can be provided to students, teachers, and library patrons who lack connected devices, such as laptop or tablet computers, or lack broadband access during the pandemic. Schools, libraries, and consortia of schools and libraries that are eligible for support under the <u>FCC's E-Rate program</u> are eligible to request and receive support through the Emergency Connectivity Fund Program.

On Tuesday, August 3, starting at 2:00 PM EDT, the FCC will host a virtual webinar to provide additional information about the Emergency Connectivity Fund (ECF) Program. This webinar will highlight frequently asked questions about the ECF Program and application process as well as answer program questions from potential ECF participants.

Registration is not required for the event. It will be a live webcast.

New KitKeeper Tutorial

An updated KitKeeper tutorial has been recorded and uploaded to our YouTube Channel and our Niche Academy. This tutorial provides an overview of how to search for kits and fill out the reservation form. Other topics include how to select between book club kits and non-book club kits.

- Book club kits can be checked out by patrons as well as schools and librarians.
- STEM, STEAM, display, and other education kits are only available to schools and libraries.
- Teachers wanting to check out a STEM kit must ask their school librarian to fill out the reservation form. Reservation forms for STEM kits for public libraries must be filled out by the librarian or appropriate program manager.
- The number of kits that can be checked out at one time is three.
- The loan period of all kits is eight weeks.
- Borrowers are responsible for damaged or missing components.


