E-Rate in North Dakota

If you are a new director and have come across a folder marked "E-Rate" and wondered what the heck this is, then, let me help answer a few questions for you.

What is E-rate?

E-rate is one component of the Universal Service Fund that specifically addresses schools and public libraries. The Universal Service Fund (USF) consists of money collected from telecommunications companies that is dedicated to increasing high speed internet access to schools, libraries, rural health services, tribal lands, and areas of the country where the costs of broadband is higher than more urban or populated areas.

Where does USAC Get the Money?

Universal service is paid for by contributions from telecommunications carriers, including wireline and wireless companies, and interconnected Voice over Internet Protocol (VoIP) providers, including cable companies that provide voice service, based on an assessment of their interstate and international end-user revenues. If you ever looked on your phone bill or cable bill and say a fee for Universal Fund, this is where the money comes from.

What's our library's role in E-rate?

North Dakota applies for E-rate through two consortiums. If you find paperwork with StageNET or North Dakota Public Library E-Rate Consortium at the top, you are part of the E-rate Consortiums. What the North Dakota Information Technology EduTech department is filing is what is known as a State Master Contract with E-rate. This contract is for a bulk broadband service spread out to members of the consortium. Your library is not responsible for filing the application or the bid for services. We still need from you two forms filled out every year, a Letter of agency and a Form 479. I will be e-mailing a copy of these forms to participants in the beginning of October.

What is a Letter of Agency?

The Letter of Agency is a written agreement stating that you, as a library, are willing to allow the consortium coordinator to file the E-rate forms on your behalf. You need to keep a copy of this letter in your E-rate files.

What's the Form 479 for?

A Form 479 Schools and Libraries Universal Service Certification by Administrative Authority to Billed Entity of Compliance with the Children's Internet Protection Act is a declaration that your library is compliant with the CIPA Guidelines. I always include instructions on how to fill out this form. For more information about CIPA, visit https://www.fcc.gov/consumers/guides/childrens-internet-protection-act.

If I filled them out last year, do I have to fill it out this year? Yes.

How do I get my signed forms back to you?

These forms can be physically mailed back to AI Peterson, North Dakota State Library, 604 East Boulevard Ave, Bismarck, ND 58505.

If you would prefer to scan them, you can send it through e-mail to alpeterson@nd.gov. Please keep the originals in your E-rate files for ten years. That way, if we ever get audited by the FCC, we can go back ten years to show compliance.

Lastly, if you are attending this year's NDLA Conference in Fargo, you can bring the finished forms with you and hand them to me or leave them at the North Dakota State Library's booth.




